What are your data protection rights?

The right to access – You have the right to request Enginef Operations Limited for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Enginef Operations Limited correct any information you believe is inaccurate. You also have the right to request Enginef Operations Limited to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Enginef Operations Limited erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Enginef Operations Limited restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Our Company's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Enginef Operations Limited transfer the data that we have collected to another organization, or directly to you, under certain conditions.

What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

- **Functionality** – Enginef Operations Limited uses these cookies so that we recognize you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.
- **Advertising** – Enginef Operations Limited uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. Enginef Operations Limited sometimes shares some limited aspects of this data with third parties for advertising purposes. We may also share online data collected through cookies with our advertising partners. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.
